- 1. Acceptance cutoff time is as below:
  - a. DG cargo
    - 1. PAX 6hrs before flight departure
    - 2. Freighter 8hrs before flight departure
  - b. <u>All other cargo</u>
    - 1. Freighter 8hrs before flight departure
    - 2. PAX 4hrs before flight departure
    - 3. Re-Export Minimum 12hrs before STD
  - 2. Rates for handling and storage charges are based on Gross Weight or Chargeable Weight whichever is higher.
  - 3. All charges will be rounded up to the next 100bz at the total charge level (per receipt).
  - 4. Special cargo consist of Dangerous goods (DG), Live animals (AVI), pharmaceutical cargo (PIL), Perishable cargo (PER), Diplomatic mail (DIP), Valuable cargo (VAL), Courier (COU), Vulnerable (VUN),Heavy cargo (HEA) and Human remains (HUM).
  - 5. Heavy cargo (HEA) is more than 150KG per piece.
  - 6. Loading /unloading charges are still applicable even if consignee use external workforce.
  - 7. For all local services (VAT) will be applicable 5%.
